

# Matching: GRF Host Country Pledges

## West and Central Africa - WCA

At the Global Refugee Forum, stakeholders made pledges towards the objectives of the Global Compact on Refugees (GCR). Matching is the process of pairing pledges made by host countries to facilitate greater inclusion, protection, and support for people forced to flee with pledges made by donors to provide the financial, material, or technical support necessary for their implementation.

### Burkina Faso

1. Pledge number 1272. **Statelessness.** Reform legislation to address gaps that are a potential source of statelessness

### Gambia

2. Pledge number 1189. **Statelessness.** Legislate to grant nationality to children born on the territory including foundlings who would otherwise be stateless

### Ghana

3. Pledge number 1121. **Multiple.** Every child enjoys free education up to senior high school. Primary health care and UHC to be provided for all, including refugees. Ensure that refugees are included in the national biometric identification system to issue them a Ghana card. Hosting areas for refugees are economic zones.

### Guinea-Bissau

4. Pledge number 1136. **Statelessness.** Finalize issuing and distributing identity cards and birth certificates for refugees, and certificates of nationality for 7000 naturalized refugees

### Liberia

5. Pledge number 1000. **Education.** 2018 Inclusive Education Policy expanded to enable education management and delivery services respond to the diverse needs of refugee learners

6. Pledge number 1313. **Jobs and Livelihoods.** Strengthening Technical and Vocational Education and Training (TVET) for refugees and host communities

### Mali

7. Pledge number 1098. **Solutions.** Expanding access to durable solutions

### Niger

8. Pledge number 1038. **Protection Capacity.** Ensure legal access to land for 40,000 refugees in mixed housing areas (hosts and refugees)

### Nigeria

9. Pledge number 1202. **Solutions.** Nigeria pledges to continue playing an active and constructive role in regional and sub-regional efforts to address the root causes of displacement

### Senegal:

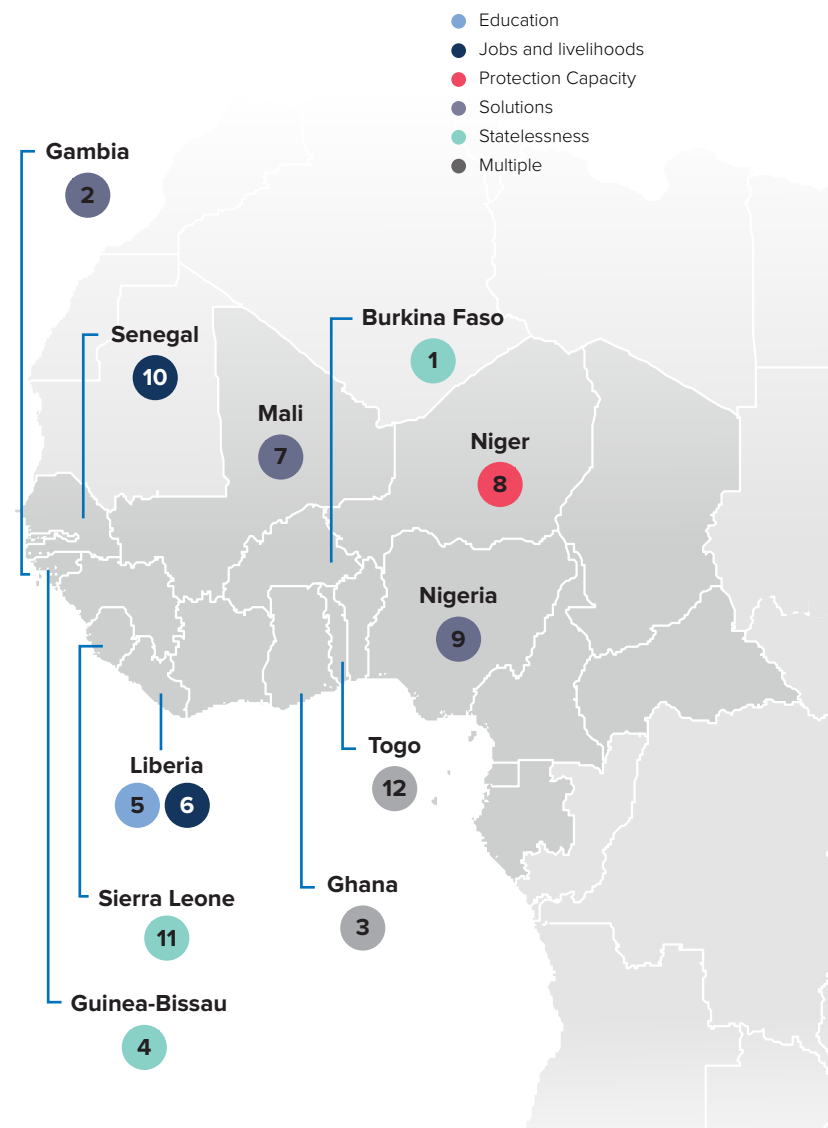
10. Pledge number 1222. **Jobs and Livelihoods.** The Republic of Senegalese undertakes to include refugees living in Senegal in the various agricultural projects and programs.

### Sierra Leone

11. Pledge number 1342. **Statelessness.** Training to build capacity of government and advocacy organizations to continue to protect and assist stateless persons in protracted situations

### Togo

12. Pledge number 1367. **Multiple.** Commitment to eradicate statelessness by 2021 and committed to work on registration and providing papers to all refugees.
