






Pledges by entity

Number of pledges by entity




% of pledges by entity


Pledges by receiving region (%)





Pledges per receiving region vs. share of POCs

- Relative representation compares a region's share of pledges compared to the region's global share of POCs.
- The high relative representation in EAH, Europe and Southern Africa suggests, in general, high attention from the international community
- The low relative representation in MENA and West and Central Africa, suggests relatively less attention from the international community
- This calls for particularly vigorous followup in areas with relatively few pledges.


